Sir,

I am directed to refer to this Department's letters No. 6-1/2010-CA.V dated
8.2.2010, 5.3.2010, 8.4.2010 and letter of even number dated 22.4.2010 on the subject
cited above. The Administrative Approval for implementation of NFSM during 2010-11
has already been issued. The State Action Plan for implementation of NFSM-Rice and
NFSM-Pulses have also been approved by Govt. of India and the approval has also been
conveyed to respective states.

In order to release funds to States/implementing agencies for implementation of
the scheme during 2010-11, it is once again requested that the following
information/material may please be furnished to this Department urgently:

- a) UC for the grants released for 2009-10 (component-wise UCs, i.e., NFSM-
Rice, NFSM-Pulses and NFSM-Publicity in GFR-19A may please be
furnished).
- b) Consolidated (i.e. cumulative) physical-cum-financial progress
report(MPRs) for 2009-10;
- c) Details of interest accrued as on 1.4.2010, on Central Grant-in-aid received
by States./implementing agencies;
- d) Final Utilization Certificate along with audit statement of accounts for
financial year 2008-09.
